PRODUCT DESCRIPTION

OLR is a rectangular overflow unit and OLC is a circular overflow unit, both made to be installed directly into a wall. OLR and OLC consists of two sound-attenuating baffles, which are mounted on either side of the wall.

Both OLR and OLC can be connected by means of the accessory OLRZ or OLCZ, which is a perforated telescope wall sleeve, which ensures excellent noise reduction. Both OLRZ and OLCZ must be ordered separately.

MANUFACTURING AND PACKAGING (A1-A3)



The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste generated in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The steel raw material is received by Lindab Group's own steel service centre, Lindab Steel AB and afterwards transported to production unit. Upon arrival, the material and all other components of the product are inspected for quality assurance.





The product parts are cut with a laser cut and punching machine (waste from these processes is pure steel scrap, steel scrap goes to recycling). Parts are formed by pressing and bending. All metal parts are painted (in this process wastewater comes out, this is treated by the subdivider). Insulation is cut into shape and mounted in the front part. All parts are assembled. The units are packed with a mixture of bubble wrap (only for OLC), cardboard and wooden pallets for protection during transportation. Lubricating oil is used for the above machines.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions. After cutting in the wall to the correct dimensions, OLR and OLC are mounted on either side of the wall. The perforated wall sleeves (OLR-Z and OLC-Z) may need to be trimmed to the appropriate length to fit properly into the wall while OLC-Z and OLR-Z might need to be cut to the correct length to fit into the wall. Installation spills are included in this stage. Handling of packaging material is considered.

Transport from production site to customer is calculated based on the market share.

PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase. These life cycle stages are dependent on how the product is used and should be developed and included as part of a holistic assessment of specific construction works.





PRODUCT END OF LIFE (C1-C4, D)

Energy (0,1kWh) for deconstruction is included in C1. Activities related to steel recycling is included in C3. A recycling rate of 85% (according to World Steel Association, 2020) and landfill rate of 15% has been assumed for the steel. See below tables for scenarios used in Modules C and D.



LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. While cut-off criteria according to the PCR were employed, much data which would have fallen within that scope were included regardless, if available, resulting in a data set which is robust and captures all significant contributors to the LCA results.

There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:
